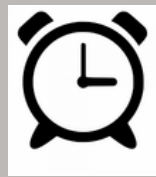

## TOURNAMENT REGULATION

- Free entry for GM's & IM's.
- Time control 15min+5sec from move 1.
- System of play: The tournament will be conducted as per latest Fide laws and Swiss system with 7 Rounds.
- Protests: If any, shall be lodged within 10 minutes of the incident with a fee of Rs 1000/-. It will be refunded if the appeal is upheld.
- Appeals Committee: Five members appeals committee will be formed. No member of the committee can vote on dispute in which a player from his own state is involved and in such cases, the reserve can take his place in the committee.
- Withdrawals: A player may withdraw at any stage of the tournament by informing the chief arbiter in writing.
