

- **Tie Break** : Buchholz Cut 1, Buchholz, Sonneborn- Berger, Direct Encounter & Greater No. of Wins. Prize Money will not be shared in case of tie
- **AICF Registration**: AICF Registration Fee of Rs. 300/- for the year 2024-2025 is compulsory
- **Protests** : Protest , if any, against the decision of the Chief Arbiter shall be made in writing with a protest fee of Rs. 1000/- within 15 minutes of the occurrence of the incident to the appeals Committe. No protest will be entertained later.
- **Withdrawals** : A Player may withdraw at any stage, after informing the Chief Arbiter in writing
