- 3. Any number of teams can participate from the same school
- 4. The championship will be played as per the latest FIDE rules
- 5. Protests, if any, against the decision of the Chief Arbiter shall be made in writing with a Protest fee of Rs. 1000/- within 15 minutes of the occurrence of the incident.
- 6. The Protest fee will not be refunded if the appeal is rejected
- 7. All participants should produce the school identity card at the time of reporting
- 8. The maximum points scores will be eligible for overall championship
- 9. All participants should be a registered player of Chess Association Kerala (CAK). CAK player registration fee is Rs.100/- for the year 2024
- 10. No spot entry allowed.
