TOURNAMENT RULES :



SYSTEM OF PLAY

The Tournament will be conducted as per FIDE laws of Chess and FIDE Swiss System with 7 rounds.

TIME CONTROL

45 minutes plus 15 secs increment from move 1 for entire game.

TIE BREAK

In case of a tie, the Latest FIDE rules shall come into effect. The cash prizes will however will not be shared.

DEFAULT TIME

The default time will be 30 minutes.

ELECTRONIC DEVICES

All Electronic devices including Wrist watches (all type of watches) are not allowed in the tournament hall.

WITHDRAWAL

A Player may withdraw at any stage of the event after informing the Chief Arbiter in Writing.



APPEAL COMMITTEE:

BEFORE THE COMMENCEMENT OF THE TOURNAMENT, AN APPEAL COMMITTEE WILL BE FORMED. THE DECISION OF THE APPEAL COMMITTEE WILL BE FINAL.

PROTEST:

PROTEST, IF ANY, AGAINST THE DECISION OF THE CHIEF ARBITER SHOULD BE IN WRITING WITH A PROTEST FEE OF RS 1000/- WITHIN 30 MINUTES OF THE OCCURRENCE OF THE INCIDENT TO THE APPEAL COMMITTEE.
