TOURNAMENT RULES AND REGULATIONS

- System of Play:** The Tournament will be conducted as per FIDE Laws of Chess and FIDE Swiss System with 9 Rounds.
- Time Control:** 15 Minutes + 5 Seconds increment from move 1 for entire game.
- Reporting Time:** All players should Report at 9.00 am. Tournament First round will start at 9.30 am.
- Tie Breaks:** In case of a tie, the following Tie Break Rules will be followed
 - Buchholz cut 1**
 - Buchholz**
 - SB**
 - Direct Encounter**
 - Greater number of wins (including forfeit points)**
 - Greater number of wins with black**
- Appeals Committee:** Before the commencement of the tournament, a five-member appeals committee shall be formed by the organizers.
- Protest:** Protest, if any, against the decision of the Chief Arbiter shall be made in writing with a protest fee of Rs.1000/- within 15 minutes of the occurrence of the incident. The protest fee will be refunded if the appeal is upheld otherwise amount will be forfeited
- AICF Registration for 2024-2025 is Mandatory for players willing to participate.**
AICF Registration should be done before registration of tournament.

13. **Electronic Devices:** Those who are having mobile phones/electronic devises or wearing watches during their play will be declared lost.
14. **Accommodation:** Players will have to make their own arrangement for stay.
