

Late Fee:

Please note entry fee structure is valid till 20 March 2025. Thereafter a late fee of Rs.250/- per player will be levied. No entry will be entertained after 24th March 2025 (up to 17:00 hrs.).

System of Play:

The Tournament will be played under FIDE's Laws of Chess and the Swiss system. A total of nine rounds shall be played.

Default Time:

Default time for arriving to the chessboard is 15 minutes.

Time Control:

The rate of play shall be 90 minutes with an increment of 30 seconds per move from move number one.

Tie Break: Following is the order of tie-break:

(a) Buchholz Cut1, (b) Buchholz, (c) Sonneborn Berger, (d) Direct encounter, (e) The greater number of wins (forfeit included), (f) The greater number of wins by black Draw Agreement:

Players shall not agree for a draw without the consent of the arbiter, before each player makes 20 moves.

Protest: Protest, if any, against the decision of the Chief Arbiter shall be made in writing with a protest fee of Rs.1000/- within 15 minutes of the occurrence of the incident. The protest fee will be refunded if the appeal is up held.

Appeals Committee:

Before the commencement of the tournament, a five member appeals committee shall be formed by the ATCA.

Registration of Players with AICF:

All participants in the Tournament shall be registered with AICF for the year 2024-25.Online AICF registration can be done at the website www.aicf.in/players

Electronic Devices:

All electronic items including wrist watches (all type of watches) are not allowed in the tournament hall. Those who are having mobile phones or wearing watches during their play will be declared lost.

Accommodation:

Dormitory accommodation will be provided to interested players and parent with a minimum amount .
