System of Play

The tournament will be conducted as per FIDE Laws of Chess and FIDE Swiss System with 09 rounds .

Time Control :

25 Minutes plus 10 second increment from move 1.

Default Time

The default time will be 15 Minutes.

Tie Break :

FIDE latest Tie Break rules shall come in to effect.

Fair Play Regulations :

All electronic items including wrist watches (all type of watches) are not allowed in the tournament hall. FIDE and AICF Fair Play Regulations will be in enforce during the event and all players are to respect and abide by the same.

Accommodation & Food :

Free Dormitory is available on first come first serve basis for limited persons at the venue itself.

Later on, players are required to make their own arrangements for accommodation.

Food available on chargeable basis at venue.

Eligibility & AICF Registration :

All the Indian players must be registered with AICF for the year 2025-26.

Online AICF Registration is available in the website www.aicf.in.

All the Chhattisgarh players must be registered with CGSCA for the year 2025-26.

Date of birth proof is mandatory to claim under age category prizes

Protest :

Protest, if any against the decision of Chief Arbiter, shall be made in written with protest fee of Rs. 1,000/- within 15 minutes of the occurrence of the incidence. The amount shall be refunded if the appeal is upheld.

Appeals Committee :

Appeal committee of five members + 2 reserved shall be formed. No member of the committee can vote on dispute in which a player from himself is involved and in such cases, the reserve can take his place in the committee.

Disqualification :

No participant will leave the tournament venue before the prize distribution function without the permission of the Chief Arbiter. Otherwise, his/her prize and certificate will be forfeited, and disciplinary action will be taken.
