System of play –The tournament will be conducted as per fide laws of chess & Fide Swiss system.

Time Control – 90 minutes each with increment of 30 seconds from move number one.

Default Time – Default time will be 15 minutes.

Tie Break – In case of a tie, the latest AICF rules shall come into effect. The cash prizes, however, will not be shared. One player will be given one higher prize.

Electronic Devices – All electronics devices including wristwatches (all types of watches) are not allowed in the tournament hall.

Protest - Protest, if any against the decision of Chief Arbiter, shall be made in written with protest fee of

₹ 1,000/- within 15 minutes of the occurrence of the incidence. The amount shall be refunded if the appeal is upheld.

Appeals Committee – Five member appeal committees shall be formed according to the choise of organisers.

Registration- All the players must be registered with AICF for the year 2025-26 to participate in the tournament. Those who are not registered with AICF are required to do through following link.
