CHAMPIONSHIP RULES

- 1. Age Limit: Players should be born on or after 01-01-2014
- 2. Two players in each category from every affiliated District Association of CAK.
- 3. Any other player who remits the prescribed Special Entry Fee of Rs. 1200/-
- 4. All entries including special entries should come through the concerned affiliated District Association of Chess Association Kerala (CAK) and all the participants should be a registered player of the concerned affiliated district association. No direct entries will be entertained in any circumstances.
- 5. System of Play: The Championship will be played as per latest FIDE's Laws of Chess and the Swiss system.
- 6. Default Time: Default time for arriving to the chessboard is 15 minutes.
- 7. Tie Break: (1) Buchholz Cut 1 (2) Buchholz (3) Sonne born Berger (4) Direct Encounter (5) The greater number of wins (forfeit included)
- 8. Protest: If any against the decision of the chief Arbiter shall be made in writing with a Protest fee of Rs. 500/- within 15 minutes of the occurrence of the incident. The Protest fee will not be refunded if the appeal is rejected.
- 9. Tournament Committee: The organizer will form a tournament Committee for the smooth conduct of the championship.
- 10. Interpretation: For interpretation of the rule(s) and deciding any point not covered by the above rules of the tournament, the decision of the tournament committee shall be final and binding on all. The tournament committee has every right to make any addition of amendment to these rules, without prior notice. However such changes or inclusion will be subject to CAK clearance. Such changes will, however, displayed in the tournament hall.
- 11.A player may withdraw at any stage of the event only after informing the Chief Arbiter in writing.
- 12. No claim/complaint shall be entertained from the coaches/parents.
- 13. Electronic Devices during the play: Players are forbidden to wear any kind of wristwatch or carrying any electronic devices. If found player will be declared lost.
- 14. Eligibility for National Championship 2025 is only limited to concerned State Championship participants. Top two players from each category will be represent Kerala in the National Under 11 Chess Championship 2025-26 (Open 2, Girls 2). Writing score sheets are mandatory in National Championships.
- 15. All participants should be a registered player of Chess Association Kerala (CAK). CAK player registration fee is Rs.100/- for the year 2025.
