- 3) Spectators and Players who have finished their games, Parents, Managers and Coaches should stay away from the playing area during the rounds.
- 4) General discipline should be maintained at the tournament hall and Seating area.
- 5) Protest, if any, against the decision of Arbiter shall be madein writing with a protest fee of Rs. 1000/- within 15 minutes of the occurrence of the incident. The protest fee will be refunded if the appeal is up held. In case of any dispute the Chief Arbiter's decision will be final and binding to all.
- 6) Chief Arbiter's decision shall be final and binding to all.
- 7) Attending the **closing ceremony** of the Championship is **mandatory** for all the participants.
- 8) All the **prize winners** must **attend the Prize Distribution** Function, if not then prizes will not be handed over to any body else and the **Prize will be forfeited**.
- 9) The organizer reserves the right to admit or refuse any entry without assigning any reason thereof. Organizers also reserve the rights of admission to the venue.
- 10) Organizers have every right to make any addition or amendments to their rules, without notice, such changes however will be displayed in the tournament hall.
- 11) TieBreak system will be declared in the players meeting.
