Rules & Regulations

- The tournament shall be played under the latest FIDE Laws of Chess under Swiss League System.
- Total No. of **rounds 7** & Time control : **15m + 05s** increment from move one.
- No refund or No carry forward of entry fee will be entertained.
- A Player is entitled for only one Prize and only the higher Prize will be considered.
- Birth certificate/Aadhar card copy is mandatory for category prize eligibility.
- In case of Tie, latest tie break rules shall come in to effect.
- Any disputes will be handled by the **ARBITER**, whose decisions are final.
- The organisers of the tournament reserve the right to make any necessary changes in the rules about the tournament.
- Players & accompanying persons are requested to maintain discipline throughout the tournament.
- Protests if any against the decision of the arbiter shall be made in writing with a protest fee of Rs500 within 10minutes of the occurrence of the incident to the Appeals committee. The protest fee will be refunded only if the appeal is upheld.
- The organizers have the right to reject any entry without assigning any reason.
