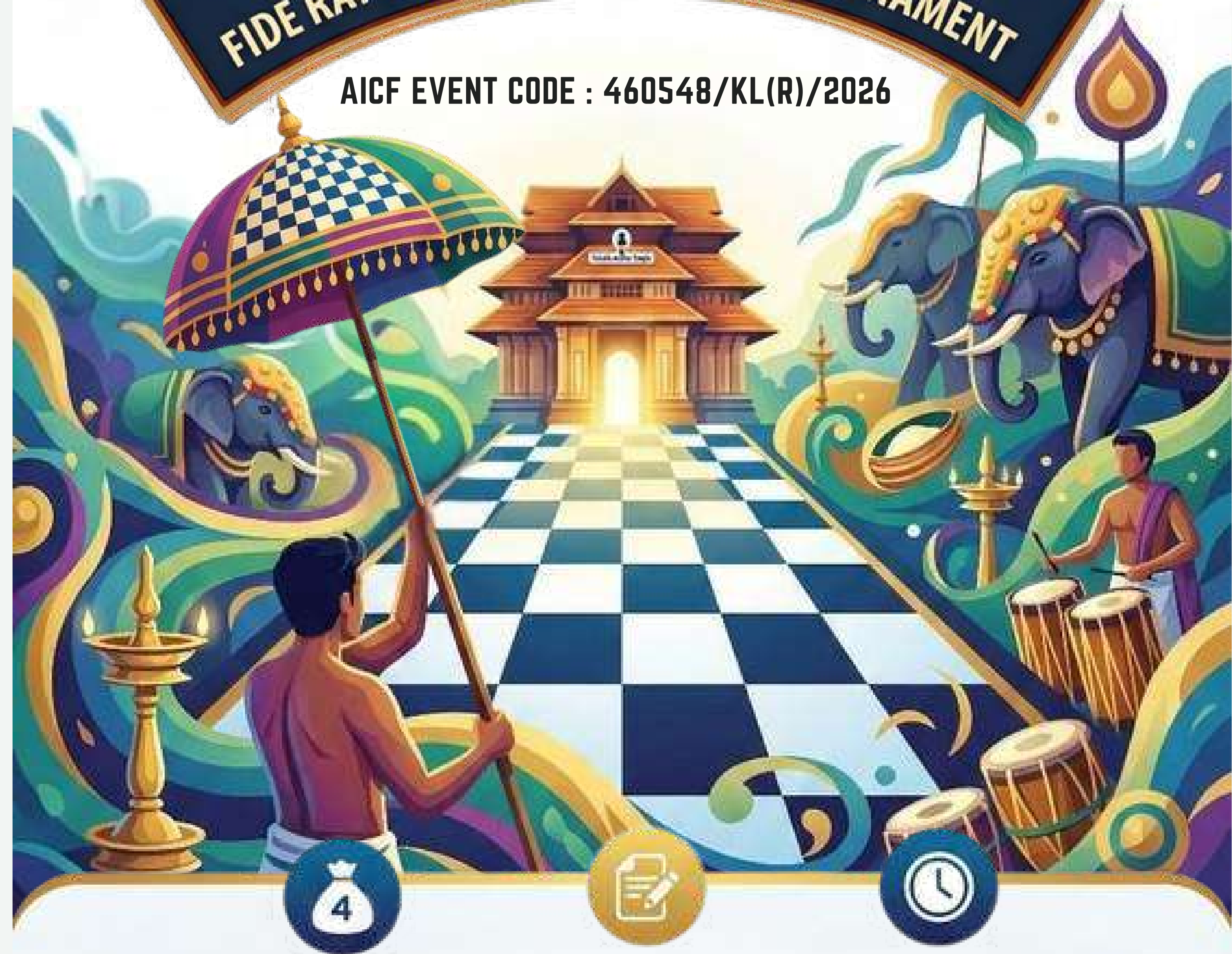

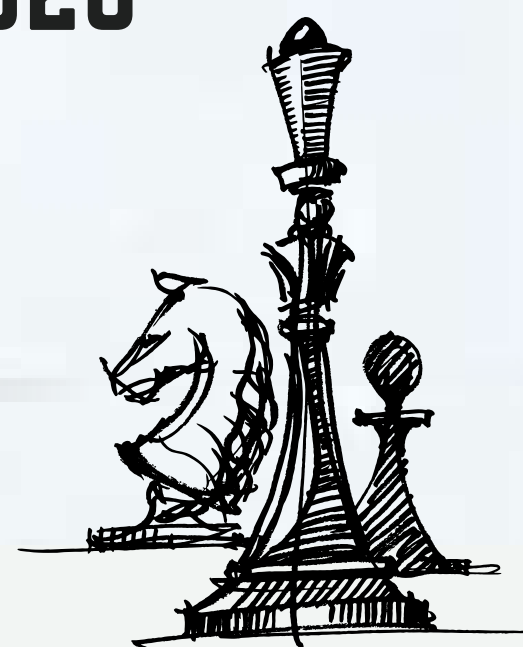
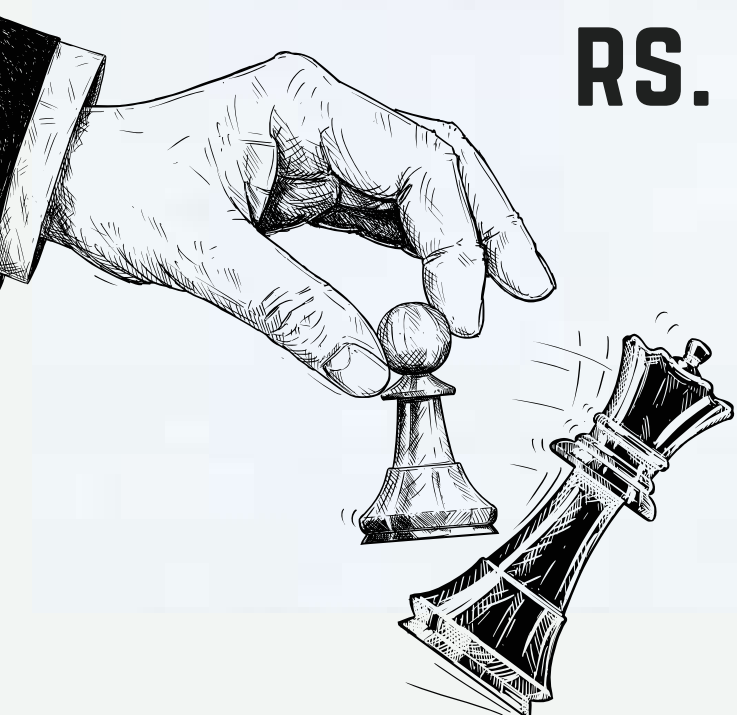

RULES AND REGULATIONS

1. System of play: FIDE Swiss System with Rapid Regulations will be followed.
2. Time Control: 10 Minutes + 03 Seconds increment from move 1.
3. The tournament will be conducted as per the latest FIDE Laws of Chess.
4. Tie-break: Will be decided by the organizing committee.
5. The break: Buchholz Cut 1, Buchholz, Sonneborn Berger, Direct Encounter, Number of wins (including forfeit points), Number of wins(With Black).
6. Players: Open to all players irrespective of the district or state. Any glitch with electronic devices may result in a loss.
7. AICF ID/AICF Registration: AICF ID/AICF Registration is compulsory for all Indian players.
8. Players registering for the event up to April 15, 2025 must send AICF ID before the start of the tournament. It will be accepted only through online.
9. For AICF player registration, copy of the paying slip should please get it from your AICF ID/player.
10. Kerala Players: AICF new registration and AICF ID and CAK Registration (Kerala Players) is compulsory.
11. AICF new registration or active AICF ID and CAK Registration (Kerala Players) is sole responsibility of the player. Players who have failed to have a valid AICF ID for the tournament will not be allowed to participate. Tournament organizers will not be responsible for late or failed AICF registration.
12. Appeals Committee: An Appeals Committee will be formed during the technical meeting.
13. Protests: Protests, if any, against the decision of the arbiter shall be made in writing with a protest fee of Rs. 1000/- (One thousand only) within 10 minutes of the occurrence of the incident. The protest fee is refundable if the protest is upheld. The decision of the appeals committee shall be final and binding.
14. Interpretation: For correct interpretation of the rules and deciding any point not covered by the rules, the decision of the tournament committee shall be final and binding.
15. Withdrawals: A player may withdraw at any stage of the event, after informing the Chief Arbiter in writing.
16. Proof of age: Compulsory for players claiming age group prize.
17. For the category prize, the organizer may ask the players for their date of birth proof, and by registering for the tournament players are agreeing to the tournament organizer's right to ask for their age proof.
18. Prize money of 10000 and above will be transferred to winners within 7 working days after the tournament.
19. Organizer has the right to admit or reject any entry without assigning any reason.
20. Organizer has the right to make any changes on the event at any time.
21. Organizer is not responsible for the accommodation, traveling, or any other problems like transportation etc for those are staying at their own arrangements or related to the tournament. Need to make your own arrangement to meet your needs.
22. Spot entry will not be accepted.

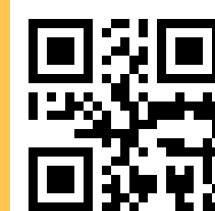
