TIME CONTROL

10 MINUTES + 5 SECONDS INCREMENT FROM MOVE ONE FOR THE ENTIRE GAME.

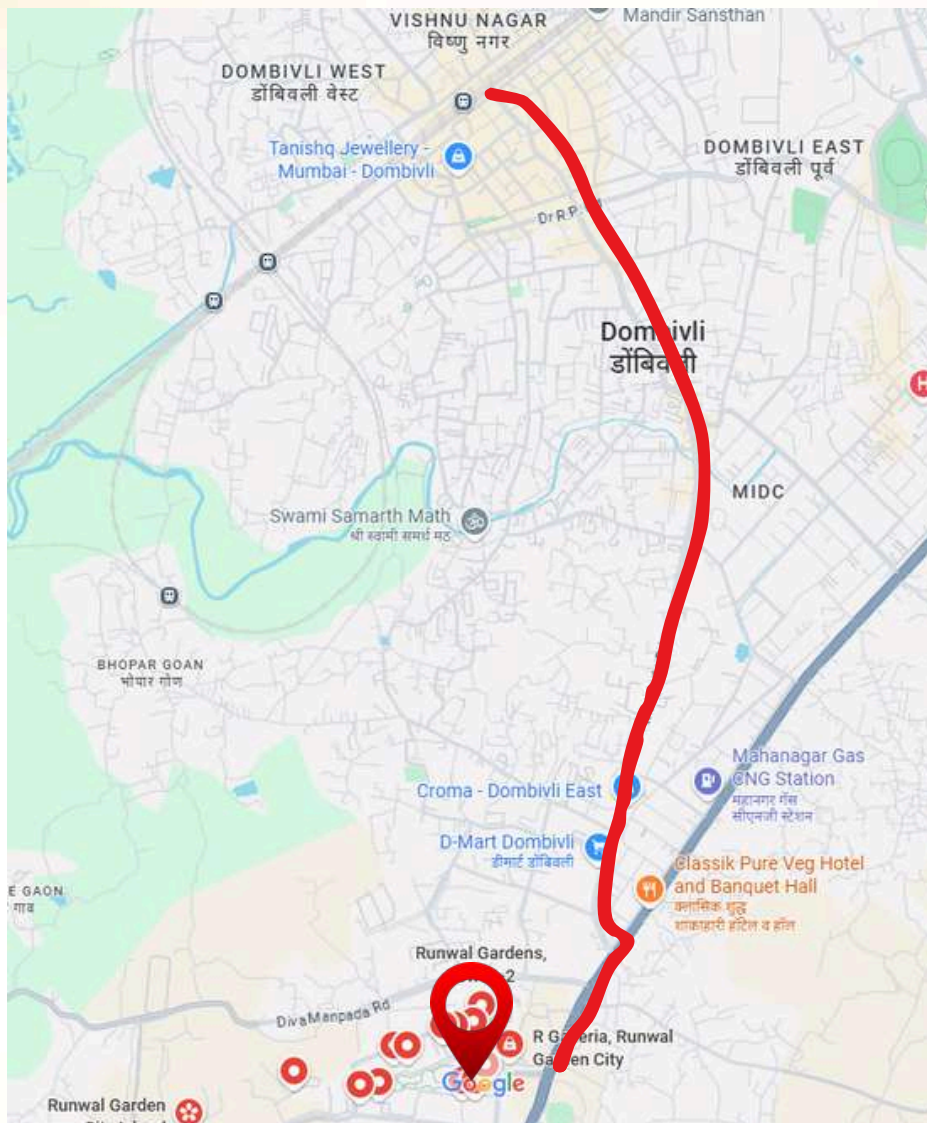
